# **Executive Director Updates**

FM We are entering the last quarter and everyone is happy to be back from spring break. We are having a problem with the septic tank near the front office. FM Discusses how the septic tank works and what is wrong with the tank. FM There are two options, we either replace/repair the cylinder or trench from the high school and connect to the county sewer. We cannot complete either until summer. DF What would the path look like through the school? FM It would have to go around the pond. It is the more expensive option.

FM There are 275 enrolled for next year and we are waiting on several to finish their enrollment. The high school still needs some growth. DF Do we know if any of these students are registering in multiple schools? FM No, we have to use the state form and it does not have a space for that question.

FM Multiple plays are happening in the coming weeks, several field trips, eighth grade and high school trips are being planned, may day, and graduations. The next eight weeks are very busy. It is an exciting time of year.
